PERMISSION IS HEREBY GIVEN FOR GEORGIA TRANSMISSION CORPORATION ("GEORGIA TRANSMISSION"), ITS AGENTS AND EMPLOYEES TO ENTER UPON THE PROPERTY IDENTIFIED ABOVE FOR THE FOLLOWING PURPOSES AND SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS:

I. PURPOSES

- To locate the corners and survey portions of the Property.
- To verify the existence, type, and location of any improvements on the Property such as structures, roadways, utilities, crops, and fences.
- To verify the natural and biological features of the Property such as its topography, ponds and water courses, soils, wildlife, trees and surface vegetation.
- To locate and survey a proposed substation site and/or survey and stake the centerline for a proposed electric transmission line, and,
- To otherwise examine, survey, appraise, test and inspect the surface and subsurface and photograph said Property and perform related studies necessary for the purpose of finalizing plans for possible electrical facilities consistent with sound engineering practices, applicable laws, and applicable regulations,
- Such entry to occur on separate occasions by persons acting for and under the direction of Georgia Transmission.

II. TERMS & CONDITIONS

1. RISK TO PERSONS ENTERING PROPERTY. Except in the case of willful injury or gross negligence, Property Owner shall not be responsible for the safety of any persons entering under this Permit. All Georgia Transmission representatives who enter upon the Property shall do so at their own risk.
2. CLEARING LINE-OF-SIGHT. Georgia Transmission may cut trees where necessary to clear lines of sight for surveying. Georgia Transmission will minimize clearing activities to only those necessary.
3. INDEMNIFICATION. Except as noted in Term 2 above, Georgia Transmission will be responsible to the Property Owner, as at law provided, for any damage done to the Property as a direct result of work performed by Georgia Transmission representatives. Also, Georgia Transmission agrees to indemnify Property Owner and save the Property Owner harmless from any claims, suits, or judgments arising out of injury to person or damage to property proximately caused by Georgia Transmission representatives.
4. TERM OF PERMIT. This Permit shall be effective from the date hereof and shall expire twenty-four months thereafter.
